

GDPR (General Data Protection Regulation)

ALLTRACO BV processes your personal data because you use or want to use the services of ALLTRACO BV.

WHAT KIND OF DATA:

ALLTRACO BV only collects the information that is necessary to provide you with the best possible service or to comply with legal obligations, this includes:

E-mail address, name, phone number, company, job description, address, website, ...

The processing takes place according to the rules of the new European privacy legislation, the GDPR. (General Data Protection Regulation).

STORAGE:

ALLTRACO BV does not store your personal data longer than is strictly necessary and / or legally required to realize the purpose for which your data is collected. Your data will not be kept longer than the legally prescribed terms.

SECURITY:

ALLTRACO BV has taken sufficient technical and organizational measures to guarantee the safe processing of your personal data. These measures correspond to the nature of the personal data and are proportionate to the potential severity of the risk and serve to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.

The risk of accidental or unauthorized destruction, loss, modification or access to and any other unauthorized processing of the data is limited to a minimum. Unfortunately, no risk can be completely avoided. If unauthorized access is obtained to the IT systems of ALLTRACO BV, we will immediately take all possible measures to minimize the damage to and / or theft of the data. If the rights of the data subjects have been damaged, a notification of data leak will be made to the Privacy Commission as well as to the data subjects.

TRANSFER:

ALLTRACO BV will only provide your personal data to third parties (inside or outside the European Union) if this is strictly necessary for the execution of the agreement with you, or to comply with a legal obligation. You can file a protest at any time.

If ALLTRACO BV uses external parties, partners or subcontractors for services, they will also have to comply with the new regulation.

COOKIES:

Using our website may lead to an automatic processing of personal data, including the IP address of your device and the time of the request and data that your browser sends. This data is used to improve the operation of the website. We try to anonymize this data as much as possible.

Functional and Required Cookies

Name	Type	Duration	Purpose
Crumb	Cookie	Session	Prevents cross-site request forgery (CSRF). CSRF is an attack vector that tricks a <i>browser</i> into taking unwanted action in an application when someone's logged in.
RecentRedirect	Cookie	30 minutes	Prevents <i>redirect</i> loops if a site has custom URL redirects. Redirect loops are bad for <i>SEO</i> .
squarespace-popup-overlay	localstorage	Persistent	Prevents the Promotional Pop-Up from displaying if a visitor dismisses it
squarespace-announcement-bar	localstorage	Persistent	Prevents the Announcement Bar from displaying if a visitor dismisses it
Test	Cookie	Session	Investigates if the <i>browser</i> supports cookies and prevents errors.

ss_cid	2 years	Identifies unique visitors and tracks a visitor's sessions on a site
ss_cvr	2 years	Identifies unique visitors and tracks a visitor's sessions on a site
ss_cvvisit	30 minutes	Identifies unique visitors and tracks a visitor's sessions on a site
ss_cvt	30 minutes	Identifies unique visitors and tracks a visitor's sessions on a site
ss_cpvisit	2 years	Identifies unique visitors and tracks a visitor's sessions on a site
ss_cookieAllowed	30 days	Remembers if a visitor agreed to placing Analytics cookies on their <i>browser</i> if a site is restricting the placement of cookies
